S3S = closed heel area, energy absorption of seat region, antistatic properties, water penetration and absorption, perforation resistance: Type PS, cleated outsole; CI = cold insulation of outsole complex; FO = resistance to fuel oil; SR = slip resistance on ceramic tile floor with glycerine.
